

SALES PROCESS GUIDELINES

01

Potential purchasers must register to be on the Hanley's Farm Database via <u>www.hanleysfarm.nz</u> – if potential purchasers are not on the database, they will not receive any information pertaining to the upcoming release/s.

02

Information such as plans for the upcoming available sections will be sent to the database a few days prior to Sale Day.

03

OPEN DAY

There will be no open day due to earthworks on site. Potential purchasers are advised to familiarise themselves with the contour/engineering plans (hanleysfarm.nz) **prior** to Sales Day. 04

SALES DAY

Pricing for available lots/sections will be released to the Hanley's Farm database **via email**

Once pricing has been released potential purchasers **<u>must</u>** email Jimmy Allen (the sales agent) at <u>jimmy.allen@bayleys.co.nz</u> to secure their preferred section **as per the strict timings stated on the pricing email.** We highly recommend back up options in case their first choice of section if not available.

If the Purchaser is able to secure a section

The Sale and Purchase Agreement (contract) will be emailed to them and they are to sign and return this contract to Jimmy Allen **as per the strict timings provided by Bayleys.** Once the contract has been received, the purchaser is to pay the 10% deposit to the **purchasers solicitor** who will then forward the funds to the vendors solicitor once they have received a fully signed contract back.
